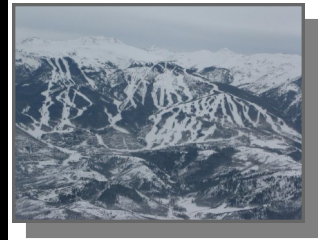

Ski The Power of Four!

Snowmass Resort lies in the heart of Colorado, about 215 miles west (and to the south) of Denver (4 hours by car). Locals will tell you they live in a banana belt of snow.



Four mountains, two geared for advanced skiers, one towards intermediates and one for beginners, comprise one of the best-known ski resorts in the ski world. Snowmass is a resort-defined town.

The Mountain(s)

As mentioned, Snowmass boasts four mountains or as the resort considers "the power of four" for its guests. Aspen Mountain (also known as Ajax) has over 3,200 vertical feet and on 700 skiable acres. It is geared toward advanced skiers as Aspen Mountain has no beginner runs. Aspen Mountain is about 9 miles to the left of Snowmass. Aspen Highlands offers 3,600 vertical on 700+ acres. The area is situated

about 6 miles to the left of Snowmass and offers a respectable amount of beginner and intermediate terrain, but 47% of the mountain is advanced terrain.

Buttermilk (also known as Tiehack) is a smaller, beginner-oriented mountain. 2,000 vertical feet and about 420 acres of smooth, rolling terrain. Buttermilk is located between Highlands and Snowmass Mountain, about 5 miles from Snowmass Village. Buttermilk is home of the X-Games and has what many believe to be the greatest "park" in Colorado.

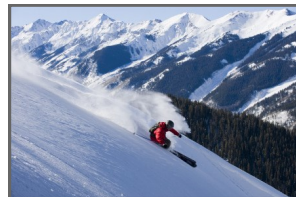
Snowmass is easily the largest of the four. Over 3,000 acres of skiable terrain, and a 4,400 foot vertical drop (measured from

absolute peak to the end of an access run somewhere in a condominium district). Terrain is varied here, though 55% is considered intermediate.

Average snowfall is around 300" (Buttermilk closer to 200").

Trip Regulations

Each person participating in a Fort Lauderdale Snow Ski Club (“Club”) trip must meet these requirements:

You must be a current, paid up member to sign up for a Club trip or to be placed on the waiting list. (You must include your new member or renewal dues with your trip deposit.

You must read, complete and agree this application in full and sign the bottom.

After the trip has filled up, vacancies (if any) will be filled from the waiting list in order of sign-up.

You agree and comply with the payment schedule presented for the trip.

It is your responsibility to have proper travel identification (such as passport, visas or driver’s license). The Club is not responsible for lost time, additional expenses incurred or total loss of a trip because you were denied boarding by an airline.

The club assumes no responsibility for any third- party transactions you may enter into as a result of your participation on this trip, e.g. trip insurance.

CANCELLATION POLICY

Any cancellation must be made in writing to the Trip Leader. You are still considered on the trip until the Trip Leader receives your written cancellation.

The cancellation fee is a minimum \$100 unless you’re transferring to another Club trip, not previously signed up for. However, the Club will also hold you accountable for any money paid to outside vendors on your behalf not refunded to the Club. The minimum cancellation fee can only be waived by the Board of Directors of the Club.

If the Club has to cancel the trip due to government directive or travel restrictions caused by additional COVID -19 outbreaks, you will receive a refund in the amount negotiated by the Club’s wholesaler with lodging properties, airlines, etc. minus a \$60.00 administrative fee retained by the wholesaler.

RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT:

I do hereby appoint the FORT LAUDERDALE SNOW SKI CLUB, INC. (“Club”), its officers, and agents, as our agents to perform all acts and to enter into any and all contracts as may be deemed desirable in connection with any ski trip or other club activity. I understand that the Club acts only as coordinator and accepts no responsibility for the services of any person, ski area, airline, motor coach, hotel, or any organization whatsoever rendering any of the services or accommodations being offered on any trip. Ski trip and other activity fees are based upon current tariffs and are subject to change without notice. The Club accepts no responsibility in whole or in part for any delays, delayed departure, or arrival, missed plane or other carrier connections, loss, damage or injury to person or property, mechanical defect or failure of any nature howsoever caused, or for any substitution of hotels or of, common carrier, with or without notice, or for any additional expenses occasioned thereby. I fully understand the Club is a voluntary association run by volunteers who have no special training in conducting ski trips or other activities. By participating, I/we do not rely on the expertise of any director, officer, activity coordinator, or the agents of any of the foregoing. I agree that I am solely responsible for my personal safety and conduct, and for meeting payment deadlines. Should I miss my departure I understand that I may not be able to recover any part of our trip or activity payment. I agree to indemnify and hold harmless, the Club, its directors, officers, and agents or contractors from any loss, cost or expense incurred by or attributable in any way to us in connection with any ski trip or other activity. I agree to abide by the Bylaws, rules and regulations of the club and the trip and the activity coordinator in connection with any ski trip or other activity.

I hereby agree to the payment schedule set up for the trip and acknowledge that failure to make payments on a timely manner could result in my being removed from the trip, with penalties.

Signing up for a FORT LAUDERDALE SNOW SKI CLUB trip implies acceptance of the regulations and agreement.
